- **7. Graystone Consulting March 31**st, **2020 Performance Report.** The total fund return for the quarter was -12.23% as compared with the policy index return of -12.80%. The performance Appendix and Asset Allocation & Time Weighted Performance are attached to the minutes. Delaware is currently under watch. The following actions were taken:
 - Rancel Caballero moved to transfer \$500,000 from cash into the portfolio on a prorata basis, rebalancing as required. Frank Ruiz seconded the motion. The motion carried unanimously.

- Frank Ruiz moved to authorize the chairman to make investment decisions between meetings that would be ratified at the next meeting. Rancel Caballero seconded the motion. The motion carried unanimously.
- **8. Vrklan Expenses** \$1,987.50 Attorney, \$444.00 Joan Wall for a total of \$2,431.50. Based on the discussion and action taken under Agenda Item 6, Frank Ruiz moved to deduct these costs from Frank Vrklan's account with the VEBA in order to avoid each member paying a prorate share of his costs. Rancel Caballero seconded the motion. The motion carried unanimously.
