7. Graystone Consulting — **December 31st, 2020 Performance Report.** Scott Owens reported that for the plan financially, 2020 had been a good year with positive returns with value outperforming growth. Last month the City had forwarded the annual member VEBA contributions made in 2020 in the amount of \$1,376,644.56. \$1,110,000.00 had been distributed to the various investment vehicles, rebalancing investments as needed to stay within the investment quidelines, with the balance left in cash for payment of claims and expenses. In

reviewing each of the investments, Mr. Scott stated that Vanguard and Boston Partners have no downside protection. Numerous changes in the real estate market had been noted in 2020.

- 8. Participant's Concerns Request to consider increasing the 20% limitation of the balance on claims for members who have less than five years to retirement. The matter was discussed by the trustees at great lengths, recognizing the extra time involved to determine which members were close to the five-year time frame and other considerations, which would be an expense born by all members. No action was taken on the request.
